1: BID SPECIFICATIONS/TERMS OF REFERENCE

1.1. BACKGROUND/ TERMS OF REFERENCE

This Expression of interest is in terms of Unserviceable Movable Assets approved for disposal by the EHC.

EHC therefore requests interested public to express their interest with proposal to purchase the unserviceable and obsolete vehicle, computer equipment, furniture, and scrapped items.

EHC invites interested firms and individuals to indicate their interest and submit quotations for the items listed in the attached annexure A.

1.2. PROPOSAL & SUBMISSION REQUIREMENTS.

- a. Bidders should carefully examine the entire TOR; Bidders should become fully aware of the nature of the proposal and conditions likely to be encountered.
- b. Proposals are to be prepared in such a way as to provide a straightforward, concise of the bidders' capabilities to satisfy the requirements of this EOI.
- c. Emphasis should be placed on: (i) conformance to the EOI instructions; (ii) responsiveness to the EOI requirements; and (iii) completeness and clarity of content.
- d. The bid documents must be in a sealed envelope.
- e. Each bidder must include the following:
 - Name of organisation/Individual;
 - Description of item (s) interested in;
 - Item (s) number
 - Mobile contactable phone number of bidder
- f. If more than 1 proposal is received on any item (s), the purchase will be decided on a highest bidder principle by the EHC bid evaluation committee.


