1. PREAMBLE

Ekurhuleni Housing Company ("EHC") is a Municipal Entity set up in 2000. It was established to undertake the development and management of rental housing stock for low and moderate-income households in the City of Ekurhuleni.

2. SCOPE OF WORK

Appointment of a Service Provider to Undertake Painting, Renovation and Maintenance Works

The scope of work entails the provision of all labour, materials, tools, equipment, transport, supervision and associated resources required to undertake painting, renovation and maintenance works to the affected units. The contractor shall prepare all walls and ceilings by scraping, sanding, cleaning and applying polyfiller where necessary to achieve a smooth and acceptable surface finish prior to painting. Ceilings shall be treated with one coat of primer and finished with two coats of white paint. Internal walls shall be painted with two coats of **Newton Glory S4000 Grey Mid Sheen Pastel**, whilst all doors, door frames and window frames shall be prepared and painted with **white enamel paint**.

The works further include the supply and installation of a new geyser complete with 22mm copper piping, capillary joints, vacuum breakers, all necessary connections, fittings, cuttings and bends, with the geyser left fully operational and in good working condition. Plumbing works also include the supply and fitting of a new toilet cistern, new wash hand basin, flexi connectors to the basin, and angle valves to all applicable water supply points. All installations shall be tested for leaks and functionality and commissioned upon completion.

Carpentry works include the fitting and painting of internal doors and one external door (labour only), ensuring proper alignment, operation and finish. Ironmongery works include the supply and installation of four mortice locksets complete with all necessary accessories and fittings.

Upon completion of the works, the contractor shall remove all rubble, waste materials and surplus items from site, leave the premises in a clean and habitable condition, and provide an **Electrical Certificate of Compliance (COC)** for the affected units. All workmanship and materials shall comply with applicable South African standards and regulations, and all installed items shall be tested and handed over in a fully functional condition.
